**ESS Membership cards:** Licenses are mandatory for Drivers. They are also available for owners, crew and associates of your race team at a cost of \$30 throughout the season. If you need additional registration forms see Kathy Costello at the ESS van/trailer. You can also print your membership forms out on our web site: [www.empiresupersprints.com](http://www.empiresupersprints.com); click on the member's page. **Your 2011 license is enclosed in this packet.** Please be aware, there is a \$5.00 replacement fee if a card is lost or destroyed.

The **Pit Board or Plasma Screen** for ESS can be found at the ESS van/trailer. We post an order of events and the lineups for the Heats, Dash, B and A-Main.

Our officials will hold a **mandatory drivers meeting** before the start of each night's race program. You, or a representative of your team, must attend and sign in at this meeting each night

**Payoff** occurs at the ESS van/trailer. Payoff normally occurs within 20 minutes of the official A-Main posting. Remember, payoff may be delayed when we have cars being teched, especially, early in the season. We ask you to make every effort possible to pick up your pay at the completion of the show to avoid any confusion later on. Be sure to send someone responsible to sign and pick up your money or make other arrangements with **Kathy Costello**. *We will **not** carry any payoff not picked up at any previous race across the border.*

**1099 Tax Forms** are enclosed with this packet. **All teams will need to complete the form.** Anyone earning over \$600 this season will be issued a 1099 in January 2012. **When filling it out be sure to indicate who is to be credited for the payoff – the driver, owner or both.** We also need the Social Security number of that person and/or the Federal ID number if you have one. **1099 forms should be turned in by July 3<sup>rd</sup> to Marlene Wickham (at 75 car).** Or mailed to Marlene Wickham at 50 West Rd., Constantia, NY 13044
